IV. Discussion/Action Items

a. Recommendation from the Budget Advisory Committee (DISCUSSION/ACTION)

Rationale: The release of the May budget revision on May 14th from the California Governor's office indicated a 54-billion-dollar statewide budget deficit. This resulted in a 10% cut to the Local Control Funding formula in educational spending for the 2020-2012 school year. The impact of the COVID-19 pandemic has caused a tremendous disruption to the educational system and multi-year fiscal implications to the California K-14 system. In anticipation of the need to review Southside revenues and reduce expenditures for upcoming school year, a budget advisory committee (BAC) was formed to make recommendations to the board. The BAC participated in a survey to prioritize expenditures and program cuts. Some items on the recommendation list must be negotiated with the SEA bargaining unit in order to be considered. Page three of the supporting documentation contains the prioritization list.

Recommendation: That the board review and approve possible areas to be cut from the budget.

Recommended Motion: Approval of program cuts and personnel furloughs

Funding Source: A 10% reduction in the Southside budget = \$200,000
