a. Education Protection Account (EPA) 2023-2024 Resolution #22-23-11 (ACTION)

Rationale: Pursuant to Article XIII, section 36 of the California Constitution, school districts and county offices of education are required to determine how the funds received from the Education Protection Account are spent in the school's jurisdiction. The language in the constitutional amendment requires that the funds shall not be used for salaries and benefits of administrators or any other administrative costs.

b. Capturing Kids Hearts Contract for services (ACTION)

Rationale: Through experiential training, expert coaching, a character-based curriculum for students, and personalized support, *Capturing Kids' Hearts*® equips professionals in K-12 education to implement transformational processes focused on social-emotional wellbeing, relationship-driven campus culture, and student connectedness. The program focuses on Cultivating relational capacity, improving school culture, strengthening trust between teachers and student, building self-managing classrooms, and creating accountability.

Mr. Ruth talked about character building and the need for a grass roots movement to address the needs of the school. But an outside program may not meet the needs of our school. He said as a board member we need to use money wisely and use our funds to make positive things happen.

Mrs. Howard mentioned that the staff is already working on things behind the screens.

Mrs. Corrigan asked how the program is different from PBIS?

Mrs. Abercrombie stated that PBIS outlines positive actions

Mr. Ruth raised a point about the discussion of values and how to address values and positive character.

Mr. Salazar spoke about a person by the name of Jerry Lopez from the Santa Clara Migrant program that did a presentation on character strengths.

Mrs. Forth talked about bringing parents back to campus and parents taking ownership of the campus. Things like the talent show felt like something that was needed

I want to speak about the Capturing Kids Hearts program that is on the open session agenda. I am speaking now since this is when I could attend, I hope that is okay. We all know that the climate at our school needs some mending.

A YEAR HOLDEN

I would like to suggest that Southside puts the purchase of CKH on hold. I have read many positive reviews on the program, but I would like to see our school look to the staff as a resource first. The Southside teachers and staff know our students and we are very interested in improving the school.

We began last school year with the faculty meeting where we sat together and brainstormed ideas about how to improve our school, culture and climate. We came up with the values that we find important, and we brainstormed ideas about how to make improvements. Once the school year started, the staff's ideas were overrun by the day to day of the school year. Perhaps staff can devote time at staff meetings each month detailing what's working and what's not. The staff at Southside knows how great our school can be and we each have good ideas to improve our culture and school. If we make this a priority, and work to implement positive changes we will see growth. By working with the staff and teachers' ideas you will also see greater staff involvement.

We have a unique school with committed, dedicated teachers and staff and the staff's ideas should be invested in before buying a packaged program.

CKH

It should be known that the \$34,500 quote will not cover all of the program's costs. Each teacher will be ½ hour out of contract hours on each day if as it says the training goes from 8-5 with an hour for lunch. Each teacher will need their hourly rate for a total of an hour.

As shown on the CKH proposal for the district, it requires a 2-day training. Teachers work 2 days prior to each school year. It has been past practice (most of my 29 years here) to have 1 to 1 and ½ of those days to prepare our classrooms and prepare the first lessons. If the two-day training takes up this time, the district will need to compensate teachers for the personal time needed to do this work, or the teacher work calendar must be extended and pay adjusted for this.
