f. Resolution for elections Application Southside School District (ACTION)

Rationale: Governing boards of the school districts of San Benito County must adopt a resolution calling for consolidation of the Governing Board Election to be held on **November 6, 2018**, setting forth the authority for ordering the election and the specifications of the election order. This resolution must be signed by an officer or clerk of the governing board and a copy filed with the County Superintendent of Schools (Education Code §5304 and §5322). Education Code §5016, amended by Stats 1977, requires boards to determine whether a tie vote shall be determined by lot or run-off election. If a run-off election is selected, it shall be held on the sixth Tuesday following the election, and the candidate whose term would have expired shall continue in office until his successor qualifies. Also, each board must determine whether the board or the candidate will pay for the Candidate's Statement included on the sample ballot.

g. Pre-K-8th grade student Accident Insurance 2018-2019 school year (ACTION)

Rationale: Purchase student accident insurance to cover all students through the California Student Accident Insurance Program (CSAIP). This program provides coverage for all student injuries that occur during school hours and while attending school sponsored activities on or off od school premises. This includes all school sponsored sports.
