 - a. Social Studies Textbook adoption (ACTION)

Rationale: The California state department of education office of Curriculum and Instruction has approved new common core Social Studies textbook options for the 2018-2019 school year. The Southside staff has reviewed Social Studies curriculum resources and has selected materials from the publisher TCI. This adoption will update the Social Studies curriculum for all grade levels and will bring the school into compliance with the state approved common core instructional materials.

Funding Source: Multiple funding sources will be used to fund the purchase of these materials and will include restricted lotto funds, carryover funds from last year and REAP account funds.

b. Authorize the Superintendent to explore contracts for a developer fee study and a with a school facility consultant (ACTION)

Rationale: In order to protect the interests of the organization and maximize the impact of future development and construction project that will impact the Southside School district it is recommended that the district enter into contracts with two specific service providers. One. A school district developer fee study is needed to update the district facility charges that are assessed on projects occurring within the district. The current fee schedule is outdated, and the district is losing funds that it is entitled to with any current development within the district. A new fee study is needed to justify the increase of developer fees that the district in school facility funding including new construction, modernization and planning. This service contract would assist the school in locating school funding sources and to verify fee proposals submitted by developer projects and impact studies.

Recommendation: Authorize the Superintendent to explore contracts with the two service providers to protect the interests of the district.

Recommended Motion: Approve and authorize the superintend to explore contract options for a developer fee study and a school facility consultant.
