Recommendation: The board approve the district recommendation of the closure of Southside School from the dates of 3/23 to 4/2.

Recommended Motion: The board approve the closure of Southside School from Monday March 23rd to April 2nd.

Rationale: In order to maintain the health and safety of our students, families, and staff, school districts throughout the county of San Benito are recommending closure to prevent the exposure and spread of the coronavirus COVID-19. Between 3/23 and 4/2 students will not be on campus. To the extent possible, staff will provide educational opportunities

through a variety of options such as distance or on-line learning and independent studies for students. The two-week period will allow Southside to retain Average Daily Attendance. Staff will work with individual students on retention and instruction to prevent academic regression. Essential staff will be on campus and teachers will have the option to work from home or in classrooms. Over 5 million students representing about 84 percent of all K-12 students in the state are affected by school closings as of March 15th. 29 of the largest 30 districts in the state are closed. Based upon the spread of the virus and the recommendation from our State and local health departments, other developments may transpire that requires board actions to ensure the safety of students, families, staff, and our community.
